*In consideration of my child's enrollment in this language school, I acknowledge and agree that:

1. The student may risk bodily injury, exposure to infectious/communicable disease, death as well as loss of or damage to property,

2. I knowingly and freely assume all such risk and

3. I, for myself, and on behalf of the said student, hereby release, hold harmless and promise not to sue the Mandarin Chinese School, its board directors, teachers, volunteers, officers, official agents and/or employees, with respect to any and all such injury, death and/or loss or damage to property.

4. I acknowledge that it is the sole responsibility of parents to <u>drop off the student no earlier than 15</u> <u>minutes before the class</u> and <u>pick up the student immediately after the school period</u>; and violations such as leaving students unattended at their non-class periods or tardiness in picking up student may result in disciplinary actions leading up to the student being expelled from school. Parents of younger students are encouraged to stay for the entire length of school.

5. I acknowledge that the school attendance policy requires parents seeking prior permission from their teacher for excused absence of their student from school. The school reserves the right to block future enrollment for any student who has accumulated three (3) unexcused absences during same semester.

I hereby grant to the school, or any of its agents, the right and permission, in respect of the photographs and video which the school or its agents have taken of me or my children, or in which I/we may be included with others, to copyright the same in its own name or otherwise; to use, reuse, publish and re-publish in the same in whole or in part, in conjunction with any printed matter in any and all media now or hereafter known, and for any purpose whatsoever, if the school so chooses.

ACC rules and regulations regarding the use of ACC premises by MCS

1. ACC is a smoke-free environment, whether indoor or outdoor. MCS is to notify all participants to observe and cooperate.

2. MCS is responsible for teaching the students to respect and care for the facility and keeping all areas clean and tidy; and to disinfect all high-touch areas such as doorknobs, light switches...etc. with disinfectant wipes prior to departure. MCS will be responsible for any property damage or loss brought upon by participants, whether intentional or negligent (e.g., forgets to shut and lock any classroom windows...etc.).

3. All students must be supervised by their parents or teachers at all times. MCS is responsible for the wellbeing and safety of all the school staff and students.

4. MCS agrees to assign four adult Recess Supervisors, two for the indoor and two for the outdoor, to supervise student activities during recess or in-between classes to ensure safety.

5. All MCS students are prohibited from playing on the Fellowship Hall stage or handling any musical instruments (piano, keyboard, drums...etc.) and audio equipment there.

6. To ensure safety, the second floor, the playground, the sanctuary, and its lobby are off limit. No chasing and running inside the building or in the parking lot.

7. Please remind the MCS parents not to send students to class too early and to pick up on time after class. If ACC Table Tennis Club is in session in the Fellowship Hall, parents are welcome to join. Parents can also read or wait quietly in the downstair Fellowship Hall Lobby and hallway.
